Privacy and Confidentiality Agreement

March 2026

INTRODUCTION

Quantiom Guardian Ministries ("the Ministry") is committed to protecting the privacy, confidentiality, and sacred trust of all its members. This Privacy and Confidentiality Agreement outlines how personal information, healing data, and transmission records are collected, used, protected, and shared within the framework of our 508(c)(1)(a) Private Membership Association.

1. INFORMATION WE COLLECT

In the course of providing sovereign healing transmissions and maintaining membership records, the Ministry may collect the following types of information:

- Full name, date of birth, and place of birth (for transmission calibration)
- Email address and phone number (for communication and delivery)
- Intake form responses including health history, intentions, and personal context
- Transmission records, scan outputs, and healing session data
- Sacred exchange (payment) records
- Guardian Practitioner credentials and certification records

2. HOW WE USE YOUR INFORMATION

All personal information collected by the Ministry is used exclusively for:

- Generating and delivering personalized healing transmissions
- Calibrating biofield scans to the individual's unique energetic signature
- Maintaining membership records and access credentials
- Communicating with members regarding their healing journey
- Processing sacred exchanges and maintaining financial records
- Improving the quality and accuracy of Vault transmissions

3. CONFIDENTIALITY OF HEALING DATA

All healing data, transmission records, intake information, and personal disclosures shared within the context of the Ministry are considered sacred and confidential. This includes but is not limited to:

- All content within generated scan transmissions and healing scrolls
- All intake form responses and personal health information
- All communications between members and practitioners
- All session notes, practitioner observations, and case records

This information will never be sold, shared with third parties, or used for commercial purposes outside the Ministry without the express written consent of the member.

4. DATA PROTECTION AND SECURITY

The Ministry employs reasonable and appropriate technical, administrative, and physical safeguards to protect member information, including:

- Encrypted data transmission via secure HTTPS protocols
- Access-restricted member portals with unique passcodes
- Limited access to personal data on a need-to-know basis
- Secure storage of financial and membership records
- Regular review of security practices and protocols

5. GUARDIAN PRACTITIONER OBLIGATIONS

All Guardian Practitioners operating under the Ministry are bound by this Privacy and Confidentiality Agreement. Practitioners agree to:

- Maintain strict confidentiality of all client information and session data
- Never disclose client identities, health information, or healing details to unauthorized parties
- Store all client records securely and in compliance with Ministry standards
- Report any suspected data breaches to the Codexkeeper immediately
- Destroy or return all client data upon termination of practitioner status

6. MEMBER RIGHTS

As a member of Quantiom Guardian Ministries, you have the right to:

- Request access to all personal information held by the Ministry

- Request correction or deletion of inaccurate personal information
- Withdraw consent for data processing at any time
- Request a complete deletion of your records upon termination of membership
- Be notified of any data breach that may affect your personal information

7. EXCEPTIONS TO CONFIDENTIALITY

The Ministry may disclose member information only in the following limited circumstances:

- When required by law or valid legal process
- When necessary to protect the safety of a member or others
- With the explicit written consent of the member
- When required for the administration of the Ministry's lawful operations

8. DATA RETENTION

Member records and transmission data are retained for the duration of active membership and for a period of one (1) year following termination of membership, after which records are securely destroyed unless otherwise requested by the member or required by law.
